Vishwamitri Bridge, Munjanaluda Lalbag Road, Vadodara-390011, is functional since 1993 and has applied for permission for sanction of UG (BHMS) course with 100 seats for the academic year 2024-25. The College has submitted the Part I information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the application, the Medical Assessment and Rating Board has observed the following shortfalls as per MSR requirements:

Hospital details

- No X-ray and USG details submitted after March 2023.
- Only 3-4 investigations done per month as per documents submitted.
- OPD and IPD records register does have provisional diagnosis, prescription with justification and follow up comments.

Considering the above observations and facilities available, Medical Assessment and Rating Board has decided to issue **Conditional Permission to Shree Mahalaxmi Mahila Homoeopathic Medical College, (Shree Shamlaji Arogya Seva Trust), Beside Gujarat Tractors Nr. Vishwamitri Bridge, Munjanaluda Lalbag Road, Vadodara-390011.with admission intake capacity of 100 seats for undergraduate (BHMS) for the academic year 2024-2025.**

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college will be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the Academic year.
